ODINANCE AMENDING SECTION 6-46 OF THE MUNICIPAL CODE OF THE  
CITY OF ROCHELLE TO CREATE TWO RESTAURANT/RECREATION LIQUOR  
LICENSE AND DELETE ONE CLUB LICENSE

**WHEREAS**, the City of Rochelle is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1, et. seq.; and

**WHEREAS**, a request has been received for an additional Restaurant/Recreation liquor license for Guaraw Entertainment Team d/b/a The Flight Deck Bar and Grill which is located at 1207 W. Gurler Road, Rochelle, IL; and,

**WHEREAS**, the Liquor Commissioner, Chet Olson, has requested the deletion of one Club License and Create one Restaurant/Recreation Liquor License for Mershon, LLC d/b/a Rochelle Golf & Steakhouse, located at Route 251 South, Rochelle, IL; and,

**WHEREAS**, the Mayor and Liquor Commissioner, Chet Olson, has reviewed the request and has no objection to the creation of an additional Restaurant/Recreation license to accommodate the request of Guaraw Entertainment Team; and,

**WHEREAS**, in light of the addition of this Restaurant/Recreation Licenses allowed by the Rochelle Municipal Code from three (4) to four (5);

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCHELLE, OGLE COUNTY, ILLINOIS**, that Section 6-46 of the Municipal Code of the City of Rochelle be amended to read as follows:

**“6-46 License-Number Limitations.** There shall be issued in the city not more than six tavern licenses, not more than one restaurant licenses, not more than six restaurant/recreation licenses, not more than three package licenses, not more than four package beer and wine licenses, not more than one restaurant beer and wine licenses, not more than two club licenses, and not more than six one-day nonprofit beer and wine licensee, per year. Not more than one one-day non profit beer and wine license shall be issued for the same date.”

This ordinance shall become effective after its passage, approval and publication as provided by law and shall modify any inconsistent provisions in the municipal code prior to this date.
