**A RESOLUTION ESTABLISHING
RMU ADVANCED COMMUNICATION SERVICES PRICING SCHEDULE
FOR FIBER OPTIC SERVICES
(EFFECTIVE JULY 1, 2013)**

WHEREAS, the City of Rochelle is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1, et. seq.; and

WHEREAS, Section 98-4 of the Rochelle Municipal Code provides that the City Council may from time to time, by resolution, establish charges and rates for utility service, including advanced communications; and

WHEREAS, the City Manager has recommended the adoption of a revised pricing schedule for advanced communications to more accurately reflect the current market rate in a competitive environment, by altering the structure of rates applicable to fiber optic services; and

WHEREAS, the City Council finds that the RMU pricing schedule for advanced communications should be revised in accordance with the recommendation;

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Rochelle as follows:

1. The attached RMU Advanced Communication Services Pricing Schedule for Fiber Optic Services is hereby approved and shall take effect on July 1, 2013, and all other rates charged by RMU for communication services shall remain in effect.
