Upgrade the Three (3) used Caterpillar D3516 model diesel engine generator sets previously purchased by RMU to include the items outlined in BHMG's report of November 12, 2015 and email of December 16, 2015:

Unit 16/17

1. Replace Louvers with weather louvers and fail to open dampers.
2. Install backdraft dampers on the existing radiator discharge and repair opening on top of module.
3. Touch up all rust spots.
4. N/A
5. N/A
6. Route all vents to the exterior of enclosure.
7. Empty and flush fuel tanks.
8. Replace exhaust bellows on Unit 16.
9. Replace silencer with catalyst/silencer combination on the exterior of unit.
10. Patch corrosion as needed.

Unit 18

1. Replace Louvers with weather louvers and fail to open dampers.
2. Install backdraft dampers on radiator outlet.
3. Paint and blast unit.
4. N/A
5. N/A
6. Route all vents to the exterior of enclosure.
7. Empty and flush fuel tanks.
8. N/A
9. Replace battery charger.
10. Replace silencer with catalyst/silencer combination on the exterior of unit.
11. Patch corrosion as needed.

All Units

1. Install all stainless steel pressure tubing for the RICE NESHAP monitoring system.
2. Install CDVR on each unit.

3. Replace all day tank site gauges or level monitors.
4. Install all new batteries and fiberglass battery boxes.
5. Install Hotstart engine heater on all units.
