The Rochelle Planning and Zoning Commission met at 6:00 p.m. on Monday, December 7, 2020 in the Council Chambers of City Hall, 420 N. 6th Street, Rochelle, IL 61068. Minutes: Wolter moved and seconded by Chiavini, "I move the minutes of the November 2, 2020 Planning and Zoning Commission meeting as presented be approved." A roll call vote was taken. Ayes: McNeilly, Myers, Wolter, Colwill, Chiavini, and Carson. Nays: none. Motion carried 6-0.

Commissioner Comments: Commissioners commented on how nice the Downtown Christmas decorations look.

Business Items: PZC-11-20, Flagg Rochelle Community Park District, 802 Jones Road, Variance of Signs. Pease stated that a notice was published in the paper and mailed to property owners. Motion made by Myers, seconded by Chiavini, "I move the Planning and Zoning Commission open the Public Hearing regarding the proposed Variance of Signs for Flagg Rochelle Community Park District for the property located at 802 Jones Road." A roll call vote was taken. Ayes: McNeilly, Myers, Wolter, Colwill, Chiavini, and Carson. Nays: none. Motion carried 6-0. The request for a variance of setbacks was pulled. The petitioner is seeking a variance of signs in order to construct a proposed electronic message board, located at 802 Jones Road, which is zoned B-2, Commercial Highway. Per Section 110-674 Prohibited Signs (5) Any flashing sign, subject to the provisions relating to non-conforming signs. Per Section 110-661 Flashing sign means any directly or indirectly illuminated sign, either stationary or animated, which exhibits changing natural or artificial light or color by any means whatsoever. Motion made by Wolter, seconded by Chiavini, "I move the Planning and Zoning Commission close the Public Hearing." A roll call vote was taken. Ayes: McNeilly, Myers, Wolter, Colwill, Chiavini, and Carson. Nays: none. Motion carried 6-0.
