**AN ORDINANCE AMENDING SECTION 26-44 OF THE
ROCHELLE MUNICIPAL CODE TO INCREASE FEES
FOR FINGERPRINTING INDIVIDUALS APPLYING
FOR PEDDLER'S PERMITS**

WHEREAS, the City of Rochelle is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1, et. seq.; and

WHEREAS, under Sec. 26-44 of the Rochelle Municipal Code, individuals applying for a peddler's permit pay a \$15.00 fee to the City for fingerprinting of the individual; and

WHEREAS, the City of Rochelle Police Department currently fingerprints and processes the fingerprints of individuals applying for a peddler's permit; and

WHEREAS, the Illinois State Police currently fingerprints and processes fingerprints of individuals applying for liquor licenses within the City, and said processing provides more detailed information on the background of the individual fingerprinted than the Police Department can provide; and

WHEREAS, the City Council finds it in the best interests of the City to utilize the Illinois State Police fingerprinting services in the application process for a peddler's permit in order to provide the City with more background information on individuals applying for peddler's permits, and that an increase in the fee charged for processing fingerprints for peddler's licenses is necessary for the City to use the Illinois State Police fingerprinting services;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCHELLE, OGLE COUNTY, ILLINOIS, as follows:

1. Sec. 26-44 of the Rochelle Municipal Code is hereby amended as shown on **Exhibit A** (additions in underline, deletions in strikethrough).

This ordinance shall become effective after its passage, approval and publication as provided by law.

Sec. 26-44. Schedule of license, permit or registration fees.

(a) All businesses, trades and occupations set forth in this section are required to obtain a license, permit or registration certificate prior to operation in the city.

(b) The amount and the period covered required by this section shall be as follows:
