

**TAX LEVY ORDINANCE**

**CITY OF ROCHELLE, ILLINOIS**

**ORDINANCE NO. 11- .**

An ordinance levying taxes for all corporate purposes for the City of Rochelle, Ogle County, Illinois, for the fiscal year beginning May 1, 2011 and ending April 30, 2012.

BE IT ORDAINED by the Mayor and City Council of the City of Rochelle, Ogle County, Illinois:

SECTION 1: That the amount hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Police and Fire Protection, General Insurance, Liability Insurance, Unemployment Insurance, Worker's Compensation, Social Security, Auditing Services, Police and Fire Pension, Illinois Municipal Retirement Fund, Street and Bridge, School Crossing Guard, Street Lighting, General Obligation Bond payments for the City of Rochelle, Ogle County, Illinois for the fiscal year beginning May 1, 2011 and ending April 30, 2012.

SECTION 2: That the amount levied for each object and purpose is placed in a separate column under the heading "Amount to be Raised by Tax Levy", which appears over same being as follows, to wit:
