AN ORDINANCE AUTHORIZING THE PURCHASE OF A VENTRAC 4500 SERIES TRACTOR AND TRACTOR EQUIPMENT WITHOUT COMPETITIVE BIDDING

WHEREAS, the City of Rochelle (“City”), County of Ogle, is a non-home rule body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1, et seq.; and

WHEREAS, the City owns and operates a golf course within its corporate limits,

WHEREAS, the golf course manager has informed staff that it is necessary for the City to utilize certain commercial equipment to properly maintain the golf course in a safe and appropriate manner; and

WHEREAS, Section 11-76.1-1 of the Illinois Municipal Code provides that the corporate authorities, upon a two-thirds vote of the corporate authorities then holding office, may purchase or lease real or personal property for public purposes pursuant to contracts or leases which provide for the consideration for such purchase or lease to be paid in annual installments during a period not exceeding 20 years; and

WHEREAS, Section 2-371 of the Rochelle Municipal Code provides that the City Council may, by a two-thirds vote of council members holding office, authorize a purchase without competitive bidding; and

WHEREAS, City Staff, after conducting a search and due inquiry, have secured a quote for equipment that fits the needs and requirements of the golf course maintenance staff; and

WHEREAS, the Mayor and City Council finds that it is in the best interest of the City and its residents to authorize the City Manager or his designee to purchase one Ventrac 4500

Series Tractor, a dual wheel kit with all terrain tires, and one 84” contour mower, without competitive bidding;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCHELLE, OGLE COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: The Preambles hereto are hereby made a part of, and operative provisions of, this Ordinance as fully as if completely repeated at length herein.

Section 2: That the City Manager or his designee is authorized to execute a purchase order in the amount of Twenty-Seven Thousand Four Hundred and Sixty-One (\$27,461.00) Dollars with Burris Equipment for one Ventrac 4500 Series Tractor, a dual wheel kit with all terrain tires, and one 84” contour mower, without competitive bidding, payable in 6 annual payments as set forth in Exhibit, attached hereto. The City Manager or his designee is also authorized to complete and submit the credit application for the purchase of the lawnmower in a form similar to Exhibit B, attached hereto.

Section 3: Any policy, resolution, or ordinance of the City that conflicts with the provisions of this Ordinance shall be and is hereby repealed to the extent of such conflict.

Section 4: That this Ordinance shall be in full force and effect from and after its adoption and approval and

Section 5: The City Clerk be and hereby is authorized and directed to publish this Ordinance in pamphlet form.
