**A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A WATER  
TOWER ANTENNA LEASE AGREEMENT**

**WHEREAS**, the City of Rochelle is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/11-1, et seq.; and

**WHEREAS**, City of Rochelle (“City”) currently operates the Rochelle Police Department and utilizes wireless telecommunications to be used for public safety communications; and

**WHEREAS**, the Village of Hillcrest, Illinois has a municipal water tower that can be utilized for antennas for the wireless telecommunications systems; and

**WHEREAS**, staff and the City Manager have negotiated a lease to affix the aforementioned wireless telecommunications equipment to the Village of Hillcrest’s municipal water tower; and

**WHEREAS**, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to enter into and execute the water tower antenna lease agreement; and

**BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF  
ROCHELLE, ILLINOIS:**

**SECTION ONE:** That the City hereby incorporates all of the recitals above into this Resolution as if fully set forth herein.

**SECTION TWO:** The Mayor and City Council of the City of Rochelle authorize the City Manager to execute a Water Tower Antenna Lease, attached as Exhibit 1, subject to review and revision by the City Attorney.

**SECTION THREE:** If any provision of this Resolution or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this resolution that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Resolution is severable.

**SECTION FOUR:** Where the conditions imposed by any provisions of this Resolution are more restrictive than comparable provisions imposed elsewhere in any other local law, resolution, resolution, rule or regulation, the regulations of this Resolution will govern.

**SECTION FIVE:** The City Clerk shall publish this Resolution in pamphlet form.

SECTION SIX: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
