AN ORDINANCE WAIVING THE COMPETITIVE BIDDING REQUIREMENTS AND AWARDING MECHANICAL, INC. CONTRACTS FOR THE PURCHASE AND INSTALLATION OF A NEW HEATING BOILER AND HVAC CONTROLS /ENERGY IMPROVEMENTS

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle, Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, while "non-home rule municipalities have the authority to enact ordinances, such ordinances may in no event conflict with state law or prohibit what a state statute expressly permits . . . A local ordinance may impose more rigorous or definite regulations in addition to those enacted by the state legislature so long as they do not conflict with the statute." (*Village of Wauconda v. Hutton,* 291 Ill. App. 3d 1058, 1060 (1997)); and

WHEREAS, the City of Rochelle has been contemplating the replacement of its boiler and HVAC system at City Hall for approximately five years; and

WHEREAS, the boiler and HVAC systems, including the HVAC controls, are obsolete and in need of replacement; and

WHEREAS, the City has utilized HVAC controls from and the services of Mechanical, Inc. to periodically repair and update its boiler and/or HVAC system at City Hall; and

WHEREAS, the RMU has received two quotes from Mechanical, Inc. for the replacement of the heating boiler and HVAC Controls and Energy Improvements, which would interface with existing proprietary equipment that was installed by Mechanical, Inc.; and

WHEREAS, the City desires to waive competitive bidding requirements and award Mechanical, Inc. the contracts for the replacement of the heating boiler and HVAC Controls and Energy Improvements as set forth Option Three of the June 15, 2018 proposal (Exhibit 1) and Quote Number 1 of the September 14, 2018 proposal (Exhibit 2); and

WHEREAS, the City may waive competitive bidding requirements by a two-thirds vote of the City Council pursuant to 65 ILCS 5/8-9-1 of the Illinois Municipal Code and Section 2-371 of the Rochelle Municipal Code; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to execute the contracts with Mechanical, Inc. for the purchase of a new heating boiler and HVAC Controls and Energy Improvements; in the amount of \$141,760.00 and \$234,595.00, respectively.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ROCHELLE, ILLINOIS:

<u>SECTION ONE</u>: That the City hereby incorporates all of the recitals above into this Ordinance as if fully set forth herein.

<u>SECTION TWO</u>: The Mayor and City Council of the City of Rochelle hereby authorize the City Manager to execute contracts with Mechanical, Inc. for the purchase of a new heating boiler and HVAC Controls and energy Improvements; substantially in form and with the same pricing terms as the quote attached hereto as <u>Exhibit 1</u> and <u>Exhibit 2</u>, both subject to review and revision as to form by the City Attorney.

<u>SECTION THREE</u>: If any provision of this Ordinance or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this ordinance that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Ordinance is severable.

<u>SECTION FOUR</u>: Where the conditions imposed by any provisions of this Ordinance are more restrictive than comparable provisions imposed elsewhere in any other local law, ordinance, resolution, rule or regulation, the regulations of this Ordinance will govern.

<u>SECTION FIVE</u>: The City Clerk shall publish this Ordinance in pamphlet form.

<u>SECTION SIX</u>: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
