**RESOLUTION AUTHORIZING THE PAYMENT OF THE CITY OF  
ROCHELLE'S LOCAL SHARE FOR ILLINOIS PROJECT No. RPJ-4580**

**WHEREAS**, the City of Rochelle is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 511-1, et seq.; and

**WHEREAS**, the City of Rochelle operates the Rochelle Municipal Airport, also known as Koritz Field, and the City has applied for and is conducting a project with the Illinois Division of Aeronautics known as Rehabilitate Municipal Airports, and

**WHEREAS**, as part of the project, the City will need to make a payment in the amount of \$93,064.00 to the Treasurer of the State of Illinois as part of its local share of the project cost for Illinois Project No. RPJ-4580; and

**WHEREAS**, the Mayor and City Council finds that it is in the best interest of the City and its residents for the City of Rochelle to payment of the City of Rochelle's local share for Project No. RPJ-4580 to the Treasure for the State of Illinois in the amount of \$93,064.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF  
ROCHELLE, ILLINOIS** as follows:

**Section 1.** The foregoing Recitals are not mere preparatory language, but are hereby incorporated in this Section 1 as if said Recitals were fully set forth.

**Section 2.** The Mayor and City Council authorize payment in the amount of \$93,064.00 to the Treasure for the State of Illinois as the City's local share for Illinois Project No. RRJ-4580.

**Section 3.** The provisions of this Resolution are severable and if any court of competent jurisdiction shall declare any portion of this Resolution to be invalid or unenforceable, said decision shall not affect any portion of this Resolution, other than the part declared invalid or unenforceable. This City Council hereby declares that it would have enacted this Resolution even with the invalid or unenforceable portion deleted.

**Section 4.** This Resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.

**Section 5.** That any resolution or motion in conflict with this Resolution is hereby repealed insofar as it conflicts with this Resolution.
