**RESOLUTION ADOPTING INTERNAL PERFORMANCE MEASURES FOR CITY
FUNCTIONS**

WHEREAS, Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the City of Rochelle (“City”), Ogle County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to “pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities.” 65 ILCS 5/1-2-1; and

WHEREAS, The City operates the Rochelle Municipal Utilities and its staff performs a multitude of other tasks related to the operation of the City as a whole; and

WHEREAS, following the adoption of the City’s 2018 Strategic Plan, staff has placed more focus on policy implementation and evaluation; and

WHEREAS, staff has been working to develop internal performance measures that enhance the City’s output and enable staff to further develop our strategic plan by gathering and monitoring data of past performance through a list of performance measures; and

WHEREAS, the staff has created an itemization of performance measures, broken down for each department and enterprise; and

WHEREAS, the staff recommends to the City Council that it adopt the performance measures as outlined in Exhibit 1, attached hereto; and

WHEREAS, it has been determined by the Corporate Authorities of the City of Rochelle that it is in the best interest of the City and its residents to adopt the performance measures as recommended by staff; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF ROCHELLE, ILLINOIS:**

SECTION ONE: That the City hereby incorporates all of the recitals above into this Resolution as if fully set forth herein.

SECTION TWO: That the City Council hereby adopts and authorizes the utilization of the performance measures as recommended by staff, in a form substantially similar to Exhibit 1, subject to final review of the City's attorney.

SECTION THREE: The City Clerk shall publish this Resolution in pamphlet form.

SECTION FOUR: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
