**AN ORDINANCE ACCEPTING AND APPROVING THE PROPOSAL OF  
BENNY’S CORNER MARKET PURSUANT TO THE 2020 VENDOR  
SITE PETROLIUM FUELING REQUEST FOR PROPOSAL**

**WHEREAS**, the City of Rochelle is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 511-1, et seq.; and

**WHEREAS**, the Illinois General Assembly granted non-home rule municipalities broad authority to “pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities.” 65 ILCS 5/1-2-1; and

**WHEREAS**, the City utilizes outside vendors to provide fuel for its vehicles and equipment. The vehicles are used by multiple departments including, but not limited to Administration, Airport, Building Division, Cemetery, Communications, Electric, Engineering, Fire, Golf Course, Police, Streets, Water, and Water Reclamation; and

**WHEREAS**, On November 26, 2019 the City issued a Request for Proposals for Vendor Site Petroleum Fueling RFP#2020-01 (“the RFP”), and

**WHEREAS**, in accordance with the RFP, on December 20, 2019 the City received and properly opened three (3) three sealed proposals; the

**WHEREAS**, after analysis of the proposals submitted, the City’s staff has concluded that the proposal submitted by Benny’s Corner Market best meets the City’s needs and is most advantageous to the City; and

**WHEREAS**, the Mayor and City Council finds that it is in the best interest of the City and its residents to accept and approve the Proposal from Benny’s Corner Market for the 2020 Vendor Site Petroleum Request for Proposal; and

**NOW, THEREFORE BE IT ORDAINED** by the Mayor and Council of the City of Rochelle as follows:

**SECTION ONE:** That the City hereby incorporates all of the recitals above into this Ordinance as if fully set forth herein.

**SECTION TWO:** The Mayor and City Council hereby accept and approve the Proposal of the Benny’s Corner Market pertaining to the 2020 Vendor Site Petroleum Request for Proposal and authorize the City Manager to execute any and all necessary agreements to memorialize the terms of said proposal in a form to be reviewed by the City Attorney.

**SECTION THREE:** If any provision of this Ordinance or application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other

provisions or applications of this ordinance that can be given effect without the invalid application or provision, and each invalid provision or invalid application of this Ordinance is severable.

SECTION FOUR: Where the conditions imposed by any provisions of this Ordinance are more restrictive than comparable provisions imposed elsewhere in any other local law, ordinance, resolution, rule or regulation, the regulations of this Ordinance will govern.

SECTION FIVE: The City Clerk shall publish this Ordinance in pamphlet form.

SECTION SIX: This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
