**RESOLUTION AUTHORIZING THE EXECUTION OF A COLLOCATION LICENSE  
AGREEMENT WITH SURF AIR WIRELESS, LLC**

**WHEREAS**, the City of Rochelle (“City”) is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5-1-1, et seq.; and

**WHEREAS**, The City owns and operates, RMU owns the Rochelle Municipal Utilities Technology Center (“the Premises”), located at 910 Technology Parkway, Rochelle, Illinois. The Technology Center has space available for collocation cages in which individual licensees can locate their telecommunications equipment; and

**WHEREAS**, Surf Air Wireless, LLC desires to have access to space on the Premises to install and operate its telecommunications equipment and cabling; and

**WHEREAS**, RMU staff have negotiated a Collocation License Agreement with Surf Air Wireless, LLC and recommends that the City enter into said agreement with Surf Air Wireless, LLC; and

**WHEREAS**, the Mayor and City Council finds that it is in the best interest of the City and its residents for the City of Rochelle to enter into a Collocation License Agreement between the City and Surf Air Wireless, LLC (attached hereto as Exhibit 1).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ROCHELLE, ILLINOIS** as follows:

SECTION ONE. The foregoing Recitals are not mere preparatory language, but are hereby incorporated in this Section 1 as if said Recitals were fully set forth.

SECTION TWO. The City Manager is authorized to execute a Collocation License Agreement, in a form substantially similar to Exhibit 1, attached hereto, subject to review and revision as to form by the City Attorney.

SECTION THREE: All prior Ordinances, Resolutions and Motions in conflict or inconsistent herewith are hereby expressly repealed but only to the extent of such conflict or inconsistency.

SECTION FOUR: This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
