The Rochelle City Council met in Regular Session at 7:15 p.m. on Monday, July 23, 2018 in the Council Chambers of City Hall; 420 N. 6th Street; Rochelle, IL 61068.

- 2) **Ordinance Amending Certain Sections of Chapter 2 Article II of the Rochelle Municipal Code pertaining to the Scheduling of City Council Meetings.** The Mayor and City Council discussed a change to the regular city council meeting time at the July 9th council meeting. The consensus at that meeting was to move the start time of the meeting to 6:30 pm instead of 7:00 pm as soon as practical. The proposed resolution changes the start time to 6:30 for meetings taking place after September 1, 2018. Motion made by Councilor D. McDermott and seconded by Councilor Shaw-Dickey, **“I move Ordinance 18-4873, an Ordinance Amending Certain Sections of Chapter 2 Article II of the Rochelle Municipal Code pertaining to the Scheduling of City Council Meetings to change the meeting time from 7:00 pm to 6:30 pm for meetings taking place after September 1, 2018, be approved.”** Roll call vote was taken. Ayes: Bearrows, Burke, D. McDermott, T. McDermott, Shaw-Dickey and Mayor Olson. Nays: None. Motion passed 6-0.
